After that time, all deposits will be forfeited to **CMV Productions, Inc.**
- In the case of any termination of this agreement, **CMV Productions, Inc.** shall be paid for all services performed, and, if applicable, not yet paid for, based upon the terms, conditions and prices set forth in this agreement.

PACKAGE THREE

Within the final video product CMV Productions, Inc. will provide the following to the client:

1. An "Introduction" section that will include up to 60 photographs of the bride and groom from newborn to present edited with "Love story interviews" conducted with the bride and groom before the wedding. This section of the video will be produced at no extra charge to the client if it is requested before the wedding. Extra pictures are \$2.00 each.
2. A "Getting Ready" section which will establish location of the wedding, wedding party, and exterior shots of the ceremony site, as well as visuals of the wedding party getting ready.
3. A "Ceremony" section that will be videotaped using three cameras (two manned and one unmanned), wireless microphones, and will include the entire ceremony
4. A "Photo-Shoot" section that will include shots of the bride, groom, and wedding party during the photo shoot, and set to music chosen by the client.
5. A "Reception" section which will include the first dance, throwing the bouquet, cutting the cake and the speeches, as well as other important moments in the reception.
6. A "Video Interviews & Greetings" section that will include your guests' special messages and greetings for you on video.
7. A "Highlights" section that will recap the most memorable footage of the day set to the music of the client's choice. Up to eight copies of this sequence will be produced for wedding party members on DVD at no additional charge. (additional highlights copies are \$6 each)
8. A "Honeymoon" section that will include a photomontage using up to 30 pictures of the bride and groom on their honeymoon set to the music of their choice. This will then transition into the closing credits that will include the names of the bride and groom, the wedding party, and other individuals who were involved during the wedding day. Extra pictures are \$2.00 each.
